1. Initial Payment

Bookings will be confirmed upon receipt of a booking form and one third of the accommodation rental. If the booking is made less than six weeks before the holiday commencement date, the full accommodation rental will be required.

2. Balance of Payment

The balance of the higher charge would be due for payment 6 weeks before the holiday commencement date. If all payment has not been received less than 21 days before the holiday commencement date we reserve the right to cancel a booking.

3. Confirmation of Booking

Once a confirmation of booking has been sent, the Hirer is responsible for the amount on the Booking Form.

4. Cancellation

If you have to cancel your holiday for any reason, this must be put in writing. Cancellation will become effective effective from the date it is received and will be subject to a charge payable by you to compensate for our losses are as follows:

5. Amenities & Liabilities

7. Bedding/Linen
